

**CATEGORICAL EXCLUSION PROJECT SUMMARY FOR
TOWN OF PAW PAW
WASTEWATER SYSTEM IMPROVEMENTS PROJECT PHASE 1
SRF NO. C-544684**

Proposed Action

The Town of Paw Paw (Exhibit 1 and Exhibit 2) owns and operates a sewer system serving 222 residential and 11 commercial customers. The system includes approximately 24,500 linear feet (LF) of sewer line, 125 manholes with accompanying apparatuses, and a 0.2 MGD Lagoon Wastewater Treatment Plant (WWTP) discharging to Dawson Run.

The proposed project is a multiphase effort to rehabilitate the sewer system in the Paw Paw area. Phase I of these efforts include an Inflow and Infiltration (I&I) study, rehabilitating the WWTP, and rehabilitating the influent pump station. The I&I study is a partial system study of two-thirds of the system (or 16,000 LF) in the older areas of the collection system consisting of flow monitoring, smoke testing, inspecting manholes, and videotaping pipes. The WWTP rehabilitation consists of dredging the lagoons, demolition of existing blowers and diffusers, installation of surface aerators, replacement of buried piping and valves, replacement of cascade for post-aeration, and rehabilitation of existing buildings within the lagoon yard. The pump station rehabilitation consists of replacing the basket screen with a manual bar screen and installing an auto dialer for operators.

Environmental Benefits

Paw Paw is under Consent Order 9913 for failure to properly operate and maintain a WWTP. In addition, it has received a number of Notices of Violation (NOV) for failure to provide adequate treatment resulting in outflow exceeding effluent limitations of contaminants. The treatment plant is in a state of disrepair; the acoustical tiles on the blower building have fallen off, the chlorine disinfection building does not have proper ventilation, the effluent flow meter building is in poor condition, and chlorine contact chamber is unusable due to deterioration. The

rehabilitation of these deteriorating units will help the WWTP meet effluent limits that discharges into Dawson Run, which is on the 303(d) List and give relief from the order.

For the pump station, the replacement of the basket screen with a finer manual bar screen will prevent large debris from passing through, and the addition of an auto dialer will notify operators when an issue is occurring at the pump station.

Categorical Exclusion Criteria

EPA regulation 40 C.F.R. §6.204(a) permits the use of categorical exclusions from the substantive environmental review requirements of the National Environmental Policy Act (NEPA). To be excluded, the action must fit within a category of action that is eligible for exclusion and must not involve any extraordinary circumstances. For most infrastructure projects, the following actions are eligible for exclusion [40 C.F.R. § 6.204(a) (1) (ii)]:

Actions relating to existing infrastructure systems that involve minor upgrading, or minor expansion of system capacity, or rehabilitation of the existing system and system components, or construction of new minor ancillary facilities adjacent to or on the same property as existing facilities. This category does not include actions that:

- a. Involve new or relocated discharges to surface or groundwater;
- b. Will likely result in the substantial increase in the volume or loading of pollutant to the receiving stream;
- c. Will provide capacity to serve a population 30% greater than the existing population;
- d. Are not supported by the state, or other regional growth plan or strategy; or
- e. Directly or indirectly involves or relates to upgrading or extending infrastructure systems primarily for the purpose of future development.

Criteria which prevent the use of a categorical exclusion are found at 40 C.F.R. §6.204(b), summarized as follows:

- (1) The action may have a significant effect on the quality of the human environment or is expected to have disproportionately high and adverse human health or environmental effects on a disadvantaged community; or
- (2) The action may affect cultural resource areas, endangered or threatened species, environmentally important natural resources, or other identified resource areas of concern; or
- (3) The action is not cost-effective or may cause public controversy about a potential environmental impact.

Analysis

The proposed project meets the criteria for a categorical exclusion. It involves the criteria, "Actions relating to existing infrastructure systems that involve minor upgrading, or minor

expansion of system capacity, or rehabilitation of the existing system and system components, or construction of new minor ancillary facilities adjacent to or on the same property as existing facilities.”

The proposed system rehabilitation will be constructed on previously disturbed property that has several other utility easements adjacent to this location.

The project does not meet any of the criteria prohibiting the issuance of a categorical exclusion.

Revocation

This conclusion can be revoked if additional and/or future information indicates any of the following:

- (1) The proposed action no longer meets the defined category due to changes in the proposed action;
- (2) Serious local or environmental issues now exist; and/or
- (3) Federal, State, or local laws may be violated.

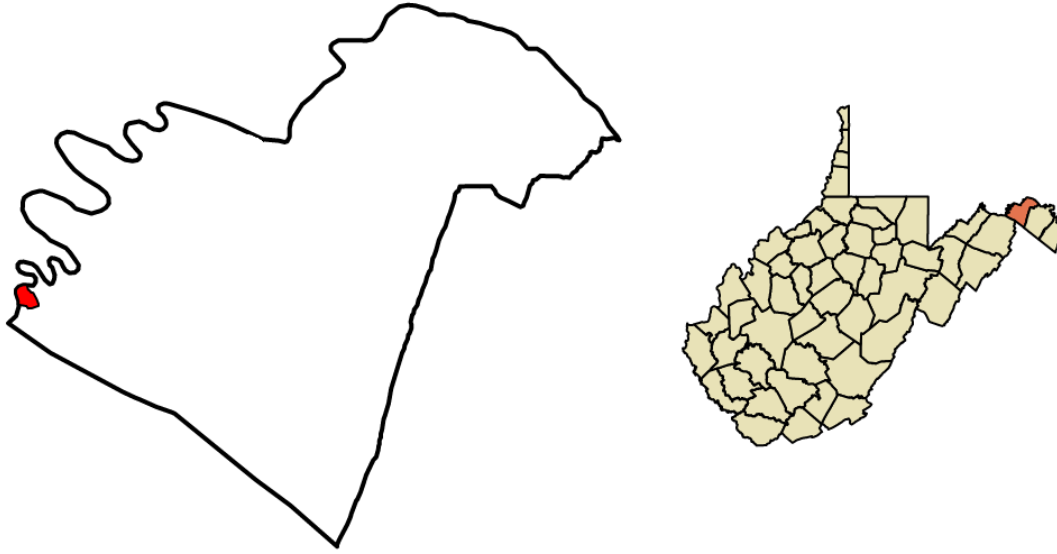

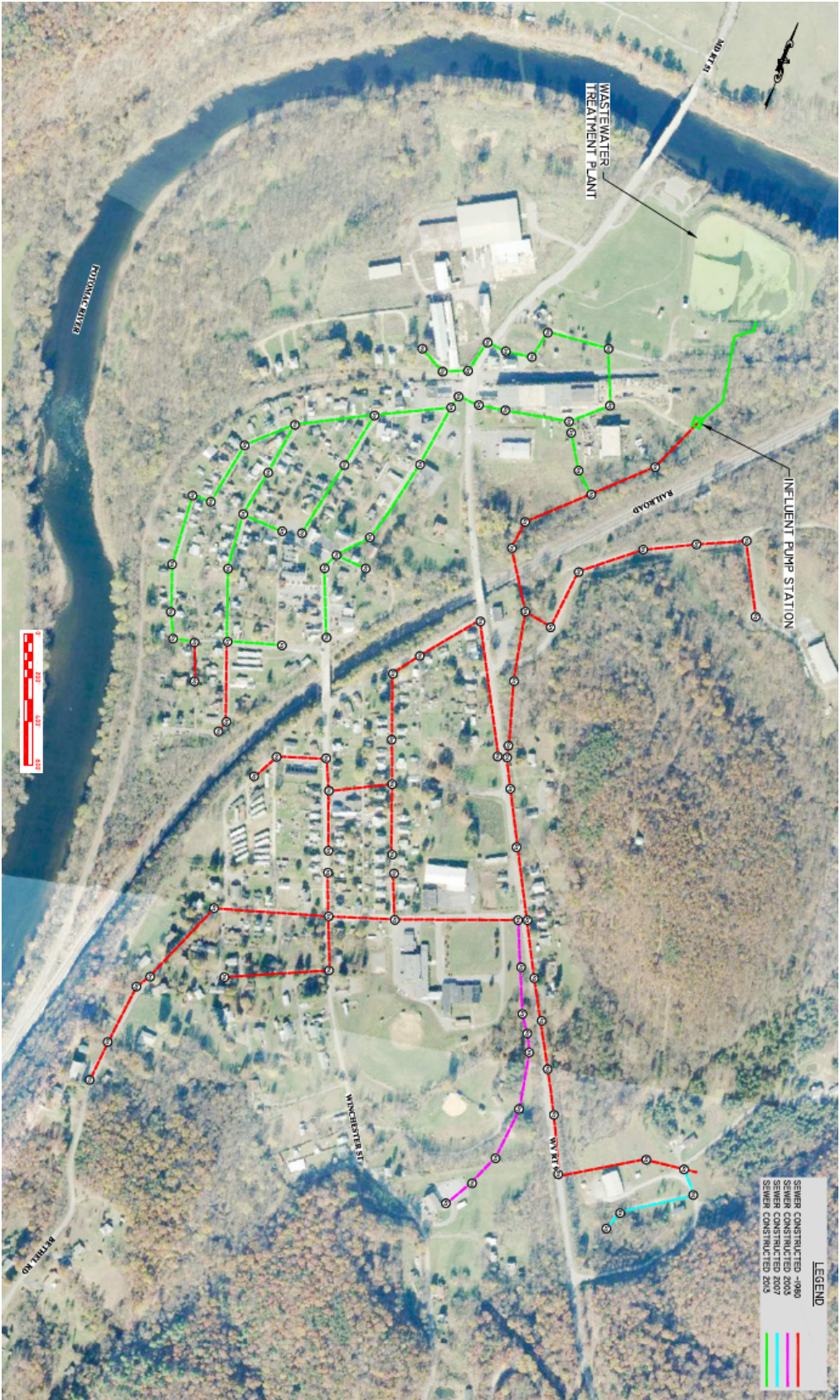
